**RESOLUTION NO. 2022-184**

**WHEREAS**, portions of APN 014-300-080 and 014-300-081 comprise Parcel A of the lot line adjustment (2022-0004 in document 2022-005699-1) equaling a 10.13 acre parcel located east of Feather River Boulevard between Broadway Road and Plumas Arboga Road, owned in fee simple by the County of Yuba; and

**WHEREAS**, the Board of Supervisors declared the aforementioned parcels as surplus land through Resolution 2021-112; and

**WHEREAS**, the Board of Supervisors previously declared the intent to sell through Resolution 2022-170, yet in conformance with Government Code 6063, sufficient notice must be given; and,

**WHEREAS**, the Board sets the new time certain to accept sealed bids and oral auction to July 26, 2022 at 9:30AM; and,

**NOW, THEREFORE** that the Board of Supervisors hereby resolves as follows:

1. The Board declares its intention to sell said property under the terms contained in the Notice attached hereto as Exhibit "A".
2. The minimum bid price for said property is two hundred and thirty thousand and no/100 DOLLARS (\$230,000). The minimum bid deposit shall be twenty three thousand and no/100 DOLLARS (\$23,000), in the form of a cashier's or certified check accompanying the bid.
3. The terms and conditions set forth in the attached Notice of Intent to Sell County Real Property are approved.
4. The Board hereby sets the date of July 26, at 9:30AM at the Yuba County Government Center, 915 8<sup>th</sup> Street, Marysville, California as the time and place where sealed proposals and auction bids shall be received and considered; and hereby delegates the CDSA Director the authority to conduct the proposed sale as provided for in Government Code Section 25539.

5. The CDSA Director is hereby directed to notice the adoption of this Resolutions and of the time and place of authorized public meetings to be given by posting copies of the Resolutions in three public places in the County, not less than fifteen (15) days prior to the date of set meeting; and publish the NOTICE OF INTENTION TO SELL REAL PROPERTY, attached hereto, pursuant to Section 6063 of the Government Code.







The property will be sold upon the terms and conditions contained in the proposed Agreement of Sale attached hereto and incorporated herein by reference.
