WHEREAS, Yuba Sutter Arts & Culture is a local non-profit arts agency that the County of Yuba has had a long-standing and collective working relationship with since 1981; and

WHEREAS, Yuba Sutter Arts & Culture is the arts agency officially designated by the County of Yuba as the local partner of the California Arts Council; and

WHEREAS, the County of Yuba and Yuba Sutter Arts & Culture mutually desire to expand and improve artistic awareness of and engagement in the arts, to encourage local communities to reach their full potential by developing arts programs that serve their needs, and to provide access to the arts in rural and under-served areas throughout Yuba County by efforts through a cooperative agreement; and

WHEREAS, the County of Yuba and Yuba Sutter Arts & Culture desire to maximize and leverage resources for Yuba Sutter Arts & Culture to play an essential role in the communities to ensure the highest quality and widest variety of arts and cultural activities and presentations are available for the community by memorializing its relationship through an agreement; and

WHEREAS, the parties hereto have the desire to work together in creating an agreement that will be used to identify and govern the relationship between the County of Yuba and Yuba Sutter Arts & Culture.

NOW, THEREFORE, BE IT RESOLVED, that the Yuba County Board of Supervisors authorizes the County Administrative Officer or designee to enter into agreements and any additional future amendments theretowith Yuba Sutter Arts & Culture to expand and improve artistic awareness of and engagement in the arts, to encourage local communities to reach their full potential by developing arts programs that serve their needs, and to provide access to the arts in rural and under-served areas throughout Yuba County so long as the agreement and any amendments thereto do not exceed twenty-five thousand dollars (\$25,000) in total and subject to the approval of County Council.
