**RESOLUTION NO. 2023-44**

**WHEREAS**, the California Department of Housing and Community Development (“Department” or “HCD”) has issued a Notice of Funding Availability (“NOFA”) for the Community Development Block Grant Program (“CDBG”), made available from the U.S. Department of Housing and Urban Development (“HUD”), pursuant to the 2022 funding year; and

**WHEREAS**, the County of Yuba (“County”) desires to submit an application to the CDBG Program pursuant to the 2022 CDBG NOFA in the amount not to exceed \$250,000 for a Yuba County Housing Survey Planning Grant; and

**WHEREAS**, County desires to use CDBG Program Income not to exceed \$250,000 towards the Yuba County Housing Survey Planning Grant activities; and

**WHEREAS**, the CDBG Program requires a resolution appointing the Director of Community Development and Services or designee as agent to execute and submit all documents including but not limited to applications, agreements, payment requests, which may be necessary for the completion of the aforementioned project.

**NOW, THEREFORE, BE IT RESOLVED**, by the Yuba County Board of Supervisors:

*Section 1.* The County has reviewed and hereby approves the submission to the California Department of Housing and Community Development, an application for a Yuba County

Housing Conditions Survey Planning Grant in the aggregate amount, not to exceed, \$250,000 pursuant to the 2022 CDBG NOFA.

*Section 2.* The County hereby approves the use of Program Income in the amount not to exceed \$250,000 for the CDBG activities described in Section 1.

*Section 3.* The County acknowledges compliance with all state and federal public participation requirements in the development of its application.

*Section 4.* The County hereby authorizes and directs the Director of Community Development and Services, or designee, to execute and deliver all applications and act on the County's behalf in all matters pertaining to all such applications.

*Section 5.* If an application is approved, the Director of Community Development and Services or designee is authorized to enter into, execute and deliver the grant agreement (i.e. Standard Agreement) and any and all subsequent amendments thereto with the State of California for the purposes of the grant, subject to approval by County Counsel.




**SECTION 6:**
