WHEREAS, California’s Homeless Coordinating and Financing Council within California’s Business, Consumer Services and Housing Agency (Agency) has made grant funds available for the Homeless Housing, Assistance, and Prevention (HHAP) Program Round 2; and

WHEREAS, the second round of HHAP Program funding is a block grant established under Assembly Bill 83 (Committee on Budget, Chapter 15, Statutes of 2020) and signed into law by Governor Gavin Newsom on June 29, 2020; and

WHEREAS, building on the regional coordination created through previous Agency grant funding, this second round of funding is intended to support local jurisdictions in their unified regional response to reduce and end homelessness; and

WHEREAS, applicants must submit an application for HHAP Program Round 2 funds in order to receive their allocation; and

WHEREAS, applicants submitting an application acknowledge that they are applying for the total amount of funds to which they are eligible for, which is calculated based on the U.S. Department of Housing and Urban Development’s official 2019 Point-in-Time (PIT) count; and

WHEREAS, Yuba County’s HHAP Program Round 2 grant allocation is \$213,528.00; and

WHEREAS, the HHSD Director seeks to apply for and be allocated HHAP Program Round 2 grant funds for Yuba County in the amount of \$213,528.00.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit an application on behalf of Yuba County for HHAP Program Round 2 grant funds.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the application and the resultant allocation for the period of July 1, 2020 through June 30, 2026; execute agreements, memorandums of understanding (MOUs) or amendments developed under the HHAP Program Round 2, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all HHAP Program Round 2 funds and any subsequent funds allocated for the stated six year period.

A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.
