RESOLUTION NO. 2021-009

WHEREAS, California Health and Safety Code (H&SC) Sections 121450, 121451 and 121452 authorize the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) to distribute for the purpose of tuberculosis (TB) control an annual subvention, paid quarterly, to any local health department that maintains a TB control program consistent with the standards and procedures established by the CDPH TBCB; and

WHEREAS, the purpose of TB local assistance funds is to assist the current efforts of local TB programs to prevent, control, and eventually eliminate TB in California; and

WHEREAS, local health jurisdictions reporting on average less than six TB cases per year receive a Real-time Allotment (RTA) for up to five cases based on current year TB case reporting; and

WHEREAS, RTAs are issued up to three times during the fiscal year and Yuba County Health and Human Services Department (HHSD) was awarded an initial installment RTA in June of 2020 for \$218, a revised installment RTA in November of 2020 for \$6,493 and could be awarded a final installment RTA in March of 2021; and

WHEREAS, in order to accept the RTA awards of TB local assistance funds, the Acceptance of Award form must be signed and submitted for each RTA installment along with annual signing and submission of all required certification and disclosure forms; and

WHEREAS, by signing and submitting the Acceptance of Award form, this serves as an official acknowledgement of receipt of the award and an agreement to the requirements as described in the Tuberculosis Control Local Assistance Funds Standards and Procedures Manual Fiscal Year 2020-2021 and any other conditions stipulated by the CDPH TBCB.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to enter into agreement with the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) for RTA awards of TB local assistance funds for the period of July 1, 2020 through June 30, 2021; and

BE IT FURTHER RESOLVED, that the HHSD Director is hereby authorized to accept, transfer and allocate the aforementioned RTA awards, and any subsequent funds awarded or requested for the stated period; and

BE IT FURTHER RESOLVED, that the HHSD Director is authorized to execute, upon review and approval of County Counsel, any and all documents as required by the RTA awards and in accordance with the Tuberculosis Control Local Assistance Funds Standards and Procedures Manual Fiscal Year 2020-2021 for the stated period; and

A copy of the said agreements, MOUs or any amendments thereto, shall be filed in the office of the Clerk of the Board, County of Yuba.


