Recommendation

Request the Board of Supervisors to approve the reimbursement to Departments for In Lieu of Health Insurance for the Period of June 2013.

Background

Per the MOU dated March 1, 1996, eligible employees can decline health insurance for themselves and their families by signing a waiver of health coverage. Employees will receive a taxable premium in lieu of health insurance coverage. The Auditor's office brings this transaction to the board semi-annually to make a transfer covering the previous six month period.

Discussion

On June 25, 2013, the Board approved a similar action for the period of January to May 2013. This transaction covered the timeframe of the December paid January through the May paid June payroll. Only 5 months were brought before the board at that time because of the way the County treats payroll expenses, specifically the payroll expenses are considered to be expenses in the month the payroll is disbursed. Due to circumstances that arose subsequent to that decision, the County has an opportunity to change the way payroll expenses are treated and shift the expenses to the period in which they actually occurred. As part of this change, the June paid July in-lieu health care payments should be recorded as a June 2013 expense.

Fiscal Impact:

There is no additional fiscal impact to departments. This transaction will involve returning \$23,050 from the Health Insurance fund to the departments but this transaction would normally take place as per the in-lieu health care agreement already approved by the Board.

RECOMMENDATION:

The Public Works Department recommends that the Board of Supervisors approve award of the contract for the above mentioned project to the apparent low bidder, and to authorize its chair to execute the contract pending contract approval by County Counsel.

BACKGROUND:

The following roadways make up the 2013 Microsurfacing - Various Areas Project:

CSA 13	(8,075 SY)	Manna Lane
CSA 48	(36,544 SY)	South of McGowan
CSA 66A	(364,339 SY)	Plumas Lake Blvd – River Oaks Blvd Area

On Friday July 26, 2013, bids were opened for the subject project. The bids received are shown on the attached sheet.

DISCUSSION:

The work in general will consist of placing a Microsurfacing overlay and thermoplastic markings and striping where appropriate. The engineer's estimate for the project is \$1,500,000. The project is expected to be completed by mid October 2013.

COMMITTEE ACTION:

The Land Use & Public Works Committee was bypassed as the project components are included in the approved Public Works Budget.

FISCAL IMPACT:

This project will be funded through CSAs 13, 48, 66A, 66B, 66C, 66D and 69 with a small portion coming from the Road Fund for the county roads (approximately \$15,000).

MINUTES OF THE YUBA COUNTY ASSESSMENT FOR COLLECTION AND DISPOSAL OF GARBAGE Thursday, July 11, 2012 2:00p.m. Board Chambers 915 8th Street Marysville, California

CALL TO ORDER

The meeting was called to order at 2:00 p.m. by Karen Mallen with Tej Maan, Chris Thornburg and Terry Bentley present.

PUBLIC HEARING

1. Report of Delinquent Solid WasteCollection Charges And Order of Assessment

Kevin Mallen, CDSA Director, explained to those present that the Public Hearing was being held to give property owners an opportunity to voice their objection to the delinquent charges and possibly work out some type of agreement for payment in order to avoid an assessment being placed on their property.

Donnie Dunn, 1534 Third Avenue, Olivehurst, stated that he inherited the Mobile Home on 1534 Third Avenue and has been paying his bill. He explained that there is a Church on the same parcel as the Mobile Home and he is receiving two bills for the same parcel. He requested that the garbage bill for the church be waived as the church does not generate enough garbage to require the service.

Tej Maan, Environmental Health Director, suggested that Mr. Dunn call the Environmental Health Department and apply for an exclusion of garbage service for the church and have one service for his home.

Terry Bentley, Recology, stated that if Mr. Dunn would leave his contact number he would look at the records and if it shows the service was not used he would see about forgiving the bill.

Mike Hatfield, 5567 and 5565 Arboga Road stated that his renter agreed to pay for the garbage bill at both addresses and failed to pay the bill and have since disappeared from the area. Mr. Hatfield also stated that he only requires one garbage service for both addresses as they are on the same parcel.

Rosie Salazar also explained that the same family rents both houses and that is why only one garbage service is needed.

Kevin Mallen, CDSA Director, explained to Mr. Dunn that ultimately the property owner is responsible for the garbage bill.

Terry Bentley, Recology, stated that he would look at their records and, if only one service was used, he will take that off his list. Mr. Bentley also suggested that the owners apply for an exemption for the second dwelling from the Environmental Health Department.

Jose Vega, 4675 Fleming Way, stated that nobody asked him if he wanted garbage service.

Tej Maan explained to Mr. Vega that garbage service is mandatory.

Mr. Vega stated that it was unfair that he had to have garbage service.

Kevin Mallen explained to Mr. Vega that everyone in Linda, Olivehurst, and Plumas Lakes is required to have garbage service.

Mary Bracket, 5536 Wilderness, stated that she came in today to pay her bill.

Chris Thornburg, Recology, said she would meet with her after the meeting and give her a receipt.

A RESOLUTION CONFIRMING REPORT) OF DELINQUENT SOLID WASTE COLLECTION CHARGES AND ORDER OF ASSESSMENT

WHEREAS, the owners of improved property within the Mandatory Pickup Areas, which are described in Chapter 7.05 of the Yuba County Ordinance Code, are required to subscribe for and pay for refuse collection services; and

WHEREAS, certain subscribers have failed to pay for such refuse collection on a timely basis, thereby accruing delinquent charges; and

WHEREAS, Recology Yuba-Sutter, has submitted to the County a report of delinquent charges referring to each separate parcel of real estate and the amount of charges proposed to be assessed; and

WHEREAS, the notice of the hearing was given in accordance with §7.05.230 of the Yuba County Ordinance Code; and

WHEREAS, a hearing was conducted wherein objections and protests from property owners liable to be assessed for the delinquent charges was heard.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors hereby confirms the special assessments against the respective parcels of land as set forth in Attachment A, attached hereto by this reference, and directs that charges imposed upon such respective parcels of land by placing them on the fiscal year 2013/2014 property tax roll. Each such assessment shall be increased by the amount of Twenty-Five Dollars for the County's administrative expenses. This will be effective for any remaining unpaid bills as of August 1, 2013.

BE IT FURTHER RESOLVED that the assessment shall be collected at the same time and in the same manner as ordinary County ad valorem property taxes are collected, and shall be subject to the same penalties and the same procedure and sale in case of delinquency as provided for those taxes.

SUBJ: Amend Professional Services Agreement – Alleghany Road over Oregon Creek Bridge Rehabilitation Project (Bridge #16C0017)

#### **RECOMMENDATION:**

The Public Works Department recommends that the Board of Supervisors approve Amendment No. 1 for the Professional Services Agreement for Civil Engineering Design for the Alleghany Road over Oregon Creek Bridge Rehabilitation Project and to authorize the chairman to execute the amendment.

#### BACKGROUND:

The Alleghany Road over Oregon Creek bridge is located approximately 0.1 mile northeast of the intersection of Highway 49 and Alleghany Road in the northeast portion of the County. The County has been working with SACOG and Caltrans to authorize funds for the design and rehabilitation of the bridge. The work done under the existing agreement includes civil engineering design, environmental, surveying, preliminary geotechnical engineering and hydraulics/hydrologly analysis. The original agreement was executed by the Board Chair on December 28, 2010.

#### **DISCUSSION:**

During the preliminary design phase it has been determined that additional envoironmental work is required to complete the NEPA process. The additional work includes a Phase 2 -Preliminary Site Assessment which will include sampling, testing and reporting of bridge components that may contain lead, asbestos or treated wood. Upon completion of the report and combined with the environmental studies already performed, we should be able to move forward with the final bridge rehabilitation design. The final design will require an additional amendment that will be processed once additional funding for the final design is made available from Caltrans.

For the additional scope of work the Consultant has requested a budget amendment of \$10,999 increasing the contract amount to a total of \$207,560.

#### **COMMITTEE ACTION:**

The Land Use and Public Works Committee was bypassed as this project is a budgeted item.

#### FISCAL IMPACT:

This bridge project is part of the federally funded Highway Bridge Program (HBP). The HBP will fund 100% (\$10,999) of the amendment cost.

#### PROFESSIONAL SERVICES AGREEMENT YUBA COUNTY PROESSIONAL CIVIL ENGINEERING SERVICES

#### AMENDMENT # 1

This is the <u>FIRST</u> amendment to the agreement, dated <u>December 28</u>, 2010, for <u>Professional Civil Engineering</u> services between the County of Yuba (COUNTY) and <u>Quincy</u> <u>Engineering</u>, Inc. (CONSULTANT).

Termination Date: November 15, 2014

The term of this Agreement shall become effective on <u>November 16, 2010</u>, and shall continue in force and effect for a period of <u>FOUR</u> (4) years, unless sooner terminated in accordance with the terms of this Agreement.

#### **Professional Engineering Services**

The following is Quincy Engineering Inc. (Quincy) detailed Scope of Work and understanding of the tasks required to complete the Phase 2 Preliminary Site Assessment for the Alleghany Road over Oregon Creek project in Yuba County (County).

The Alleghany Road over Oregon Creek Bridge Replacement project (Br. No. 16C-0017) involves rehabilitating a historic wooden covered bridge in Tahoe National Forest. The existing wooden covered bridge is approximately 77 feet long by 12 feet wide and will be used for pedestrian and light vehicle traffic. The existing timber bridge is supported on rock and concrete wall type abutments. Phase 1 efforts (completed under the original agreement dated 12/28/2010) were directed to developing a preliminary strategy to restore the historic bridge which requires compliance with Section 106 of the National Historic Preservation Act and consultation with the State Historic Preservation Officer (SHPO) and also requires a Section 4(f) evaluation. Phase 2 and 3 efforts will be directed to developing the Final PS&E for the bridge and approach roadway rehabilitation, permit applications, bidding support, and construction support.

The Preliminary Site Assessment portion of the Phase 2 Scope of Work has been separated from the remaining Phase 2 and 3 efforts and is included in this scope of work.

#### PHASE 2 – ADDITIONAL PRELIMINARY ENGINEERING & STUDIES

#### TASK 5.2 – Preliminary Site Assessment

It is our understanding Caltrans has requested this assessment during the Field Review Meeting to determine the presence of lead in the existing paint, treated wood sample. Also, testing for Asbestos and Aerially Deposited Lead will be included. All sampling, testing and reporting will be completed by Taber.

Project Management: Provide Communication and coordination with Taber for delivery of the PSA.

#### Lead-Based Paint and Treated Wood Sampling

Taber proposes to collect up to six (6) samples of potentially lead-based paint on the bridge structure, up to two (2) samples of potentially leadimpacted soil below the bridge structure and up to two (2) samples of the suspected treated wood on the bridge. Samples will be collected of different paint types at several locations and analyzed for lead to determine if hazardous levels of lead may be present in the paint. Soil samples will be collected below painted portions of the bridge to determine if any lead-impacted soils are present in potential construction excavation locations. Samples will also be collected of suspected treated wood on the bridge structure.

#### Asbestos Sampling

Taber Consultants proposes to review any available as-built drawings and perform an on-site inspection of the bridge materials for evidence of asbestos-containing building materials (ACBM). Should any suspected ACBMs be identified, samples will be collected for analysis by polarized light microscopy in accordance with CARB 435 standards.

#### Aerially Deposited Lead (ADL) Sampling

Taber proposes to collect up to 18 soil samples from a total of six (6) locations along the roadway alignment to test for aerially deposited lead (ADL). Soil samples will be collected using a hand auger at 0.5, 1.5 and 2.5 feet below surface, unless refusal is encountered. Soil samples will be analyzed for total lead with two (2) of the samples additionally analyzed for pH. Should any of the total lead samples exceed 50 milligrams per kilogram (mg/kg) lead, those samples will be additionally analyzed by WET analysis using deionized water as the extractant to determine lead solubility in the sample. Samples exceeding 5 milligrams per liter (mg/L) lead by WET or 1,000 mg/kg total lead, will be additionally analyzed by the TCLP method. Analytical results will be evaluated to determine the applicable soil types and disposition with respect to the DTSC lead variance for Caltrans projects.
